



Validations and Warnings in Accordance with CSD Requirements

Validation Summary

A Duct Leakage Test is required when the dwelling has an FAU.

- If the Dwelling Year Built is more than 45 years from the Assessment Date the HPO Approval Number is required.
- 🛕 Be aware that you are using categorical eligibility on a job with measures from programs other than a disgorgement program. This is not validated by eCore but you may run into problems with CSD monitors if they find this to be in violation of the DAP contract.

1.Categorical Eligibility: must be a job at the same dwelling assessed within 365 days and completed within 455 days of prior eligibility certification date

2.Be aware that you are using categorical eligibility on a job with measures from programs other than a disgorgement program. This is not validated by eCore but you may run into problems with CSD monitors if they find this to be in violation of the DAP contract.




Utility Assistance Expenditures by Contract






Utility Assistance Expenditures by Program






